
Attention is invited to the Memorandum cited above.

2. A copy of the format for issue of 'Backward Tribe' Certificate is enclosed herewith. The Sub / Deputy Collectors (Revenue) may arrange for printing sufficient number of copies of this format and supply to the Taluk/Sub-Taluk Offices for issue of Certificates without any delay as there are emergent need for the issue of such certificates.

3. Regarding the Authority competent to issue the 'Backward Tribe' Certificates, it is hereby directed that besides the Tahsildar in-charge of Taluks, the Deputy Tahsildars -cum- Executive Magistrates in charge of Sub-Taluks and the Deputy Tahsildars-cum-Executive Magistrates in Taluk Offices may also issue the certificate by affixing the seal reading as "Tahsildar/Deputy Tahsildar-cum-Executive Magistrate"

4. Further, it is directed that the certificate issuing authorities shall issue the 'Backward Tribe' certificates with due care and diligence after thorough field enquiry and shall not give room for any complaints .Any deviation in this regard will be viewed seriously.


A copy of the Order in G.O.Ms. No.5/2009/WEL/SW-V dated 12.04.2010 of Chief Secretariat (Welfare), Puducherry is enclosed herewith, wherein the following castes have been notified as "Backward Tribe" in the Union Territory of Puducherry, viz.,

- 1) **Irular (including the Sub-Castes-Villi, Vettaikarar);**  
(Pondicherry and Karaikal Regions)
- 2) **Malaikuravan/Malakuravan**  
(Pondicherry, Karaikal and Yanam Regions);
- 3) **Kattunayakan**  
(Pondicherry, Karaikal & Yanam Regions);
- 4) **Yerukula**  
(Pondicherry and Yanam Regions);and
- 5) **Kuruman/ Kurumans**  
(Pondicherry region)

2. Further, it is ordered in the G.O. cited above that the above castes shall stand deleted from the Most Backward Class List of the Government of Puducherry.

3. Necessary arrangements are being made to prescribe the authorities competent to issue the 'Backward Tribes' certificates and the format for issue of 'Backward Tribes' certificates. which will be communicated shortly.
